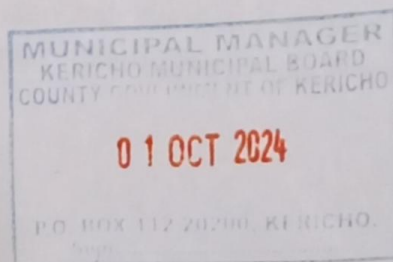

The participants also requested for another ablution block within the market since one existing collapsed.
